**CONTRACT**

permanently installed at venue and previously discussed. GRAF agrees to provide a proper, safe, easily  
accessible, sufficiently powered, area (stage or platform) for each performance.

IV. No performance by \_\_\_\_\_ may be recorded, transcribed, or re-  
created by any means whatsoever without the express permission of Band Representative.

V. This agreement may be revoked only by written notice from either Signing Party no less than \_\_\_\_\_ days  
prior to scheduled performance, or by reason of inclement weather, or bonafide emergency. If

RELATED TO EITHER GROUP, FOR ANY LIABILITY IN CONNECTION WITH THE USE OR  
POSSESSION OF THE EQUIPMENT. THIS RELEASE IS FOR ANY AND ALL LIABILITY, CLAIMS,  
SUITS, AND ACTION OF ANY NATURE FOR PERSONAL INJURIES (INCLUDING DEATH),  
FINES, PROPERTY LOSSES OR DAMAGE OCCASIONED BY, OR IN CONNECTION WITH THE  
POSSESSION OR USE OF THE EQUIPMENT.
